NOTICE INVITING TENDER

Invitation of Pre-Qualification Application for providing network connectivity services (OFC) on rental basis for running of live SIFMS in the locations specified below:-.

For and on behalf of the Governor of Sikkim, Additional Chief Secretary, Finance Department, Government of Sikkim, Gangtok, hereby invites Tender from the eligible, bonafide and experienced Contractors/Firms having work experiences with State Government/ Central Government/ Government Undertakings for Pre-Qualification for providing network connectivity services specifically on Optical Fibre Connectivity on rental basis having IP-I registration certificates and ISP-license holders and also having registered office at Gangtok, Sikkim for running of live SIFMS to PAO offices specified in the locations given below.

The eligible and intending Contractors/Firms are requested to submit their sealed tender along with Technical bid and financial bid including documents listed below, addressed to the Secretary, Revenue, Finance Department, Government of Sikkim, on or before 27/02/2020.

- (b) Financial statement showing Annual Turn Over, by attaching Audited Balanced Sheets, Profit & Loss statement for the last three years. The average annual turnover should not be less than Rs.1.00 Crores for the last three years in the field of IP-1 and ISP.
- (c) Credentials showing value of similar works successfully executed during last 2 years, giving details of such services provided with their values, year of commencement, year of completion, name of client, certificate of completion of works from the client, clients contact person & telephone numbers for cross verification may also be provided.
- (d) Solvency Certificate from the Banks.
- (e) List of Optical Fibre infrastructure held by the Contractor/Firms and which will be made available for the proposed rental/lease line network for uninterrupted connectivity of SIFMS in the location specified.
- (f) Details of Key Personnel held on the employment of the Contractors/Firms, giving their names, designation and knowledge /experience, which will be made available for the proposed rental lease line.
- (g) IP-I registration certificates and ISP- license.
- (h) Sealed tender to be submitted by the firm who has worked on Optical Fibre Connectivity and not wireless connection.
- (i) If the last date of receiving sealed tender falls on a holiday, the Sealed tender will be received on the next working day.
- (j) Estimated Rates for 12/24 core Optical Fibre for OPEX(1 Gig, 200 mbps) as given in Annexure-I which is provided in the departmental website under the link "OFC N.I.T Details".
- (k) The financial bid shall be opened only of those firm/tenderer who qualifies the technical bid.
- (l) Earnest money deposit 2.5% of Estimated cost.
