INVITATION OF BIDS

Invitation of Pre-Qualification Application are re-invited for providing network connectivity services (OFC) on rental basis for running of live SIFMS in the locations specified below:-.

For and on behalf of the Governor of Sikkim, Additional Chief Secretary, Finance Department, Government of Sikkim, Gangtok, hereby invites Re-Tender from the eligible, bonafide and experienced Contractors/Firms having work experiences with State Government/ Central Government/ Government Undertakings for Pre-Qualification for providing network connectivity services specifically on Optical Fibre Connectivity on rental basis having IP-I registration certificates and ISP-license holders and also having registered office at Gangtok, Sikkim for running of live SIFMS to PAO offices specified in the locations given below.

- II. Period :- 2021-24 (April to March). The contract is for 3 years as per terms and conditions.
- III. The eligible and intending Contractors/Firms are requested to submit their sealed tender along with Technical bid and financial bid including documents listed below, addressed to the Secretary Cum Controller, Finance Department, Government of Sikkim, on or before 07/01/2021.
- IV. The detail technical evaluation shall be done of those firms, who fulfils all the criteria listed in Minimum Required Eligibility Conditions and non fulfilling any of the condition shall be considered as disqualified.

MINIMUM ELIGIBILITY CONDITIONS:-

The following shall be the minimum eligibility criteria for fulfilling the Technical evaluation. A Proof in support of the criterion shall be submitted along with the bids. The Financial evaluation shall be carried out only in respect of those bidders whose bid meets the Technical criterion.

- 1. The agency should have minimum two years' experience in providing services consecutively in the Government departments / Public sectors (Central or State) / Private limited company at the time of submitting the tender with annual turnover of Rs 50 Lakhs or more. Attested copies of at least two work orders during each of last two years must be enclosed in the tender document.
- 2. Experience/Certificate for completion of work for past projects should be attached.
- 3. List of Optical Fibre infrastructure and Technical Manpower held by the Contractor/Firms. Separate Inspection and spot verification shall be conducted by the committee for verification.
- 4. Must possess IP-I registration certificates and ISP- license.
- 5. Only those firms who has worked on Optical Fibre Connectivity shall be considered as eligible for Technical bids.
- 6. Earnest money deposit of Rs185250. in favour of Deputy Director(Accounts), Finance should be enclosed along with financial bid and copy of which shall be enclosed in Technical bid.
- 7. Bank Receipt of Rs15000/- credited to 0070-00-800 other receipts from state Bank of Sikkim should be submitted along with the bids.

In addition to the above the following criteria/documents shall be considered for eligible:-

- (a) Registered Company Profile
- (b) Solvency Certificate from the Banks.
- (c) Self undertaking by the firm to comply with the safety requirements and provide his workmen with safety equipment where ever necessary as per existing laws of the country.
